Name of organisations

Barnsley Premier Leisure (BPL) and Focus on Young People in Bassetlaw (FOYPIB)

Starting point (what did they already do, know?)

Angela Dainty from BPL and Noelle Barron from FOYPIB have worked together to support Bassetlaw Young Carers for many years. Since 2018 they have put on events for Young Carers under the age of 14 at Christmas and at Easter, in collaboration with the Young Carers Notts Service. They have also previously funded gym memberships for young carers.

FOYPIB have funding available that is designated specifically for Young Carers, and they work with BPL to fund and organise these events with, gifts, crafts, entertainers etc.

Unfortunately, due to lack of take up from the Young Carers, the Christmas 2023 and Easter 2024 events had to be cancelled at short notice. This was very disappointing for them and for the Young Carers who had signed up. During this time they were also feeling the effects of not yet having a Bassetlaw Young Carer Support Worker in place at the Young Carers Notts Service, as the previous one had left the post when the services changed over.

Work completed (as much detail as possible)

Angela plus two other staff members from BPL received our Young Carer Awareness Training in February 2024.

Noelle plus one other staff member from FOYPIB also received our Young Carer Awareness Training in February 2024.

Both organisations expressed an interest in working towards their Young Carer Friendly Quality Mark.

Beth Choo (NCA) met with Angela and Noelle individually to go through the Quality Mark Assessment and to set them action points to achieve for their separate organisations.

All services and organisations are working together, and relationships and communications are very strong.


Young Carers in Bassetlaw are being listened to and any support offers are being tailored around their needs.
